

DIRECTIONS:

MUST ADD WATER FOR ACTIVATION. Shake well before use. Mix at a 64:1 ratio.

GALLON	2-6 OZ	4-12 TBSP
QUART	0.5-1.5 OZ	1-3 TBSP
LITER	15-45 ML	

Test for sensitivity on small area of plant.

Apply solution away from direct or intense light and in a sweeping motion. Using your preferred spraying method, thoroughly spray the underside of the foliage and the root zone. Saturate the plant until runoff.

Rinse plant with water.

Seedlings can be treated after they have been established and product can be applied one week prior to harvest
